Reopening New York/Suffolk County

NYS has established seven metrics for reopening businesses, which when met for an individual region, will begin in phases. The good news is the Long Island Region (Suffolk and Nassau) has met five of the seven, and a sixth, the hiring of a sufficient number of contract tracers, is expected to be fulfilled shortly. New York State is still hiring contact tracers! New York State will hire and train a team of staff working remotely to support the NYS Department of Health and local health departments to perform COVID-19 contact tracing in communities across NYS. The responsibility of a Contact Tracers is to reach out to the contacts of anyone diagnosed with COVID-19 to assess symptoms, ensure compliance with quarantine, and determine social support needs. Beach Openings

Suffolk County

Suffolk County beaches will be open to Suffolk County residents only. To gain entrance, you can either present your Suffolk County Green Key or your drivers license with your Suffolk County address. Suffolk County ocean beaches at Smith Point and Cupsogue County Parks will be staffed with lifeguards. Social distancing rules apply.

Riverhead Town

Riverhead Town beaches will continued to be opened for passive use. Social distancing and mask required if social distancing cannot be maintained.

Southold Town

From the Southold Town website:

Beach, Road End and Boat Ramp use continues to be restricted to "Residents Only". All vehicles must have a "Resident Parking" permit displayed. This requirement will be strictly enforced. For residents who have not yet been able purchase a permit, they are available from the Drive-Through building at the Southold Town Annex (the former Capital One Building) on Route 25 in Southold. Hours are Saturday, Sunday and Memorial Day Monday from 9 am until 3 pm. Parking stickers that were to expire on December 31, 2019 shall be valid until June 14, 2020.

Childhood Inflammatory Disease Related to COVID-19

From the NYS Department of Health website:

Children have been significantly less affected by COVID-19, as only 1 percent of New Yorkers who have been hospitalized were under 20 years old.

However, the State Department of Health is investigating 161 reported cases and 3 deaths in New York of children - predominantly school-aged - experiencing symptoms similar to Kawasaki disease and toxic shock-like syndrome, possibly due to COVID-19.

Of the children displaying these symptoms, 92 percent tested positive for COVID-19 either by diagnostic, antibody testing or both.

Voters should receive their ballot applications in the next few days.


If you return your ballot application, you will receive an official paper ballot in the mail within two weeks of the election.

SUFFOR COUNTY DISTRICT ATTORNEY'S OFFICE COVID-19 Scam Alert



As the COVID-19 pandemic continues to impact our communities, many criminals are seizing upon people's fear surrounding the health crisis and using it to scam victims out of their hard-earned money. The Suffolk County District Attorney's Office is aggressively investigating and prosecuting these offenders, but we need your help.

Testing, Treatment & Medical Supplies Scams: Scammers are selling fake at-home test kits, cures, vaccines and other unproven treatments or fake medical supplies for COVID-19. Supplies may be counterfeit or non-existent and never delivered to the consumer.



Stimulus Check Scams: Fraudsters may call or send a text or email claiming to be from the government and requesting personal identifying information before the stimulus check can be released.



Charity Scams: Criminals are soliciting donations through the creation of fraudulent charities, then stealing funds meant for individuals, groups and areas affected by COVID-19.



Fraudulent Medical Billing: People are being contacted by phone and email by individuals pretending to be doctors and hospitals that have treated a friend or relative for COVID-19, and demanding payment for that treatment.



Phishing Schemes: Scammers pose as health authorities, including the World Health Organization and the Centers for Disease Control and Prevention, to send phishing emails designed to trick recipients into downloading malware or providing personal identifying and financial information.



Price Gouging: Unscrupulous sellers are marking up prices for goods and services necessary for the health, safety, and welfare of consumers, including hand sanitizers and other disinfecting products, toilet paper and basic food items.
